Repositioning and taking on the Egan Company name directly addresses the customer need for local contractors to deliver more complex, multi-trade projects.

"We looked at the Nietz brand, core services, strengths, and future opportunities and decided it was time to bring Nietz Electric under one name in order to be consistent and current with our offerings," said Duane Hendricks, Egan Company Chief Operating Officer. "This will help us continue to integrate our Company internally and externally to represent the safety, quality, and promises we deliver to our customers."
